Following an election at the regular meeting April 3, C. M. Graves was elected trustee for a two-year term. A. C. Evans was elected guide for a one-year term.

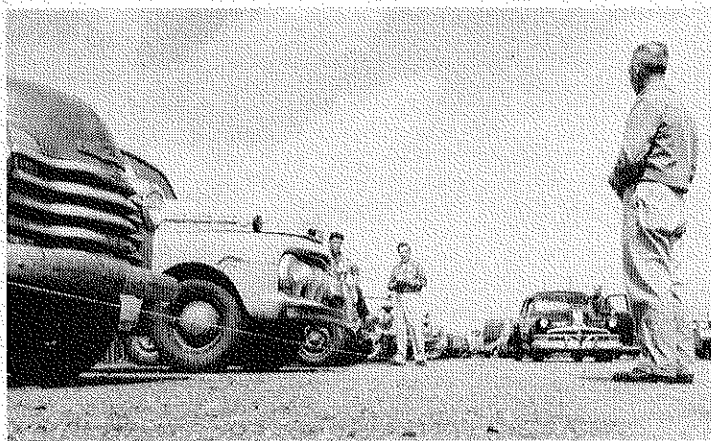
Gilbert And Sullivan Operetta To Be Given In Waverly, May 17-18

Surplus Vehicles To Be Sold May 16

Any GAT employee interested in purchasing pickup trucks, sedans or other types of vehicles which have been used on the plantsite will have an opportunity to submit bids on this property beginning Saturday, May 10. The bids will be opened on May 16, and successful bidders notified. They will then have until 4:00 p. m., May 23, to pay for and remove their property from plantsite.

Up for sale are a total of 37 pickup trucks, three panel trucks, 13 sedans, five jeeps, 19 carryalls, two truck tractors, four stake or flat bed trucks, one air compressor, and miscellaneous vehicle parts. Altogether, there are 90 "lots" of used property which make up the "spot bid" sale. The property is located at the surplus & salvage sales warehouse 1, located inside the perimeter road, northwest of the GAT Training Building.

No deposit is required with a bid. Purchased vehicles will be delivered to the buyer as soon as payment is made in full either by cash, money order, cashier's check, or certified check made payable to Goodyear Atomic Corporation.

The vehicles and spare parts will be offered "as is-where is." Bidders will be permitted to make a thorough inspection of the vehicles, but may not start the engines. Before submitting a bid, each person must agree to make his bid good if it is the high offer for a particular "lot." Bids may be made on as many items as desired.

The material may be inspected at the sale location from 10:00 a. m. until 2:00 p. m. on May 10, during the same hours Monday through Thursday, May 12-15, and from 10:00 a. m. until bids are closed for each lot on May 16.

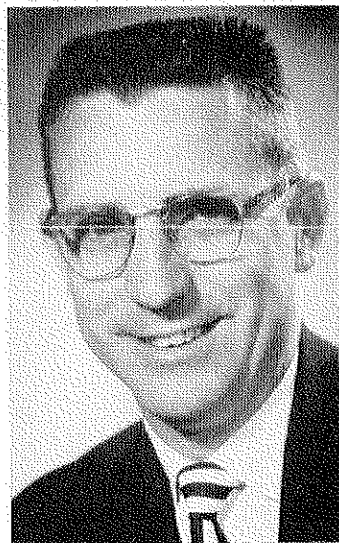
The comparison of bids and award of each lot will begin at 12:30 p. m. on May 16. The bidder does not have to be present at the time the bids are opened.

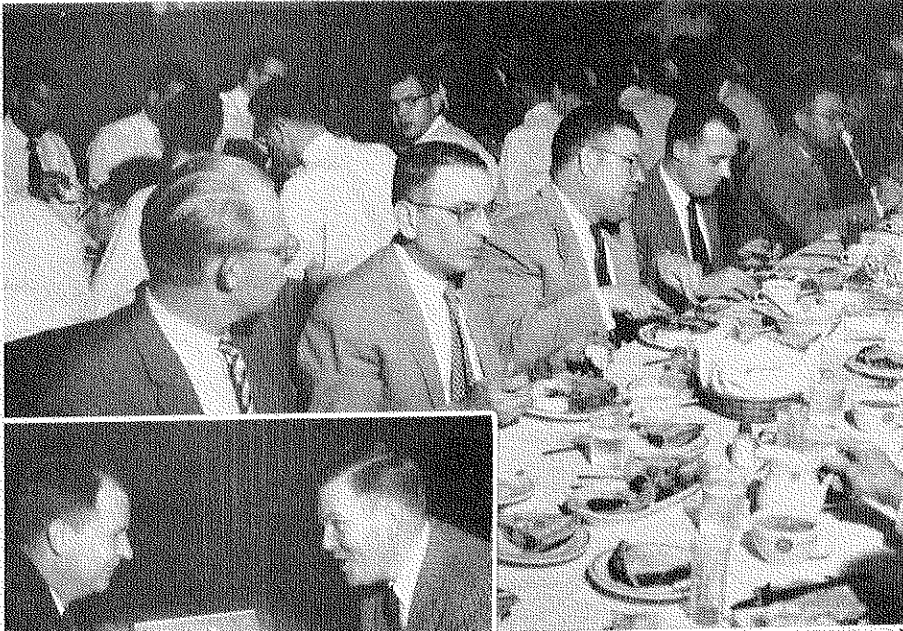

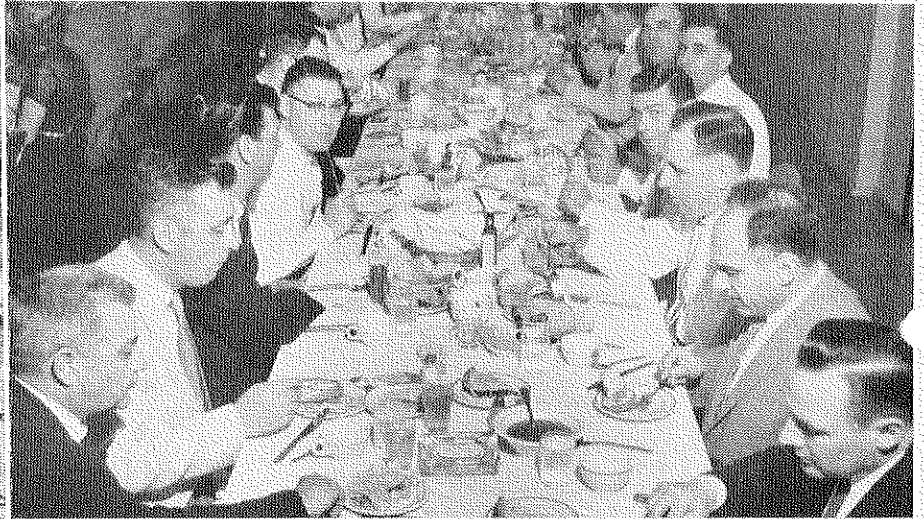

A LETTER FROM THE HILLS

The following letter was sent to the Wingfoot Clan office by a GAT employee. We think the concern for our safety as expressed by the writer, though stated humorously is serious enough to be reprinted for all employees to read:

"Mr. Wingfoot Clan —

Pleze ecus my ritin 4 i live in the hills up Ross Co way and i aint much on spelin. A mishonairee was up or way & told me about yur xpert engineers an how you can figer anything out. you see since my corn converter blew up i dont make corn into white likker enee more so i am lookin 4 a new business. I see you have a couple parking lots like the big bear has only your cars are racing criss-cross, back & forth & up & down all at once yet it looks like you have 4 or 5 race track running into a hill with one track. But in the middle of the race cars stop for people to get on & off — Could your high power enguners figure out how many you kill a day as I need a new business and a undertaker mite pay off there!!!"

No one has been killed on our plantsite parking lots, but there have been enough narrow escapes, enough close shaves, to justify someone dying from heart failure if not from physical injury.

As the letter writer said, people drive in all sorts of crazy ways in the parking lots. We've seen times at the end of the day when cars were speeding to all points of the compass while pedestrians were dodging and ducking and trying to look in front of, in back of, and to each side of their path, all at the same time.

We've seen people, normally the most courteous of individuals, act like wild savages when they start for home. Men who stand and hold doors for others while at work insist on sticking their cars into a line of traffic right in front of a speeding vehicle, just so they can save approximately 60 seconds. Employees walking into the parking lots are forced to sidestep to avoid being struck by people obsessed by one thought — get out of the lot first.

Some day, unless the driving habits of many employees improve, someone is going to hit a fellow employee who is walking in one of the parking lots. Such an accident will be all the more unfortunate and regrettable because it will be so uncalled-for.

Let's end the speeding and the heedless criss-crossing of traffic in the parking lots. Take a little more time, exercise a little more caution, be as courteous in your car as out of it, and you won't have the injury of a fellow employee on your conscience.

INDUSTRIAL RELATIONS DIVISION

This is the sixth in a series of articles written for the "Clan" which explains the activities of the various divisions of Goodyear Atomic. This article, which explains the functions and activities of the industrial relations division, was written by A. L. Williamson of the industrial relations division staff.



A. L. Williamson

The activities of the industrial relations division consist primarily of services performed for, or in support of, all GAT employees. In order to carry out its work, the industrial relations division is divided into three subdivisions—medical, personnel services, and industrial engineering. The division staff and the community relations and recreation departments are under the direct supervision of the division manager.

Staff

In the office of the division manager, many types of activities are carried out. Here administrative details are handled including the preparation of certain personnel reports required by the Atomic Energy Commission. Staff members also accomplish labor relations functions, including contract negotiations and the handling of grievances.

The community relations department serves as a liaison between the Company and the surrounding communities in which employees reside. It also acts as the center from which all information concerning the company, and community and public relations efforts are coordinated. Some of its major functions include the organization and administration of the All-In-One Campaign and the GAT Blood Bank Program, the publication of "The Wingfoot Clan, Atomic Edition", the offering of counseling service to GAT employees, and the release of corporate items

The recreation department exists for the purpose of meeting the recreational needs of as many employees and members of their families as is possible. This objective is accomplished through an organized recreational program which consists of company-sponsored activities such as the annual picnic, Christmas party, banquet of champions and company-wide dances; assistance in the organization of clubs and social organizations; the organization of athletic activities such as basketball, bowling and golf, and special activities such as the garden program and golf play-days.

Medical

The medical subdivision administers a program of preventive and corrective medicine for the detection, prevention and medical care of industrial injuries, occupational diseases, and such other non-occupational procedures as may be necessary to preserve the health and well-being of GAT employees while at work.

The medical subdivision is made up of two departments—medical services department (hospital) and the health physics and industrial hygiene department.

The facilities of the GAT hospital are available to all employees on a round-the-clock basis. It is equipped to handle all types of emergency treatment for industrial injuries and occupational diseases. Some of the activities carried on by the hospital include the conducting of physical examinations, the fitting and issuance of safety glasses and ear defenders, and routine tests.

The health physics and industrial hygiene department is responsible for recognizing, measuring and reporting all abnormal conditions which might prove harmful to both GAT personnel and neighboring communities. These abnormal conditions could be caused by any of the following agents: radiation, chemical, toxic agents, unsanitary conditions, high temperature, and noise hazards created by plant operations. This department also is responsible for making appropriate recommendations for the control of such potential hazards.

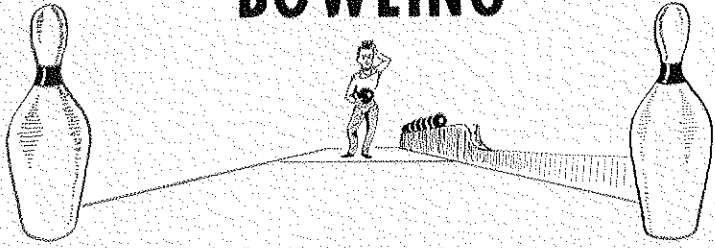
Personnel Services

The personnel services subdivision fulfills its responsibilities through the following departments: wage and salary standards, employment, training, and standard practice.

The wage and salary standards department assists management in the formulation of wage and salary policies and is responsible for administering established policies. This department conducts annual surveys to assure that wage and salary levels at GAT are at least comparable to those of other industries within a 100-mile radius of plantsite.

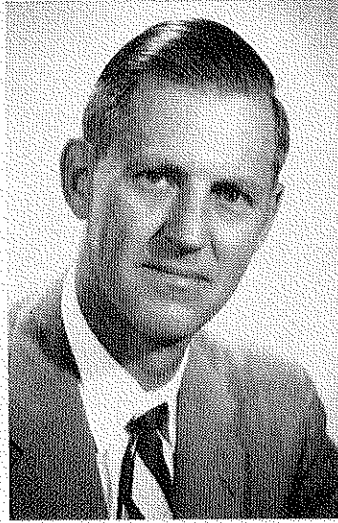

Regulations Are Outlined For GAT Garden Program

The GAT garden program for 1958 is in full swing. All garden lots located in Chillicothe, Piketon, Portsmouth and Waverly have been assigned to employees.

Certain regulations have been established by the Recreation Department. They are as follows:

(1) All tomato stakes, bean poles, small marking stakes, strings, cords, and clothes lines must be removed by October 15, 1958.

(2) Strings and cords should not be tied to the lot markers or the middle stake put in by the Recreation Department.

(3) Corn stalks should not be cut down.

(4) If a lot is accepted and then not used, the employee involved will not be assigned a garden lot next year.

(5) Lots not used by employees should be returned to the Recreation Department for reassignment.

Two hundred thirty-nine lots have been assigned this year to employees from: Chillicothe — 25; Piketon — 25; Portsmouth — 34; and Waverly — 155.

1958 Bowling Plans Set Up By Committee

The bowling program for the 1958-59 season has been announced by Jim Shoemaker, chairman of the GAT men's bowling committee.

The following tournaments will be conducted during the '58-'59 season: mixed outing, company handicap, telegraphic, scratch singles, and shift.

The percentage of handicaps for all tournaments will be 80 percent of 180 for the singles, 360 for the doubles, and 900 for the team.

The mixed outing will be followed by a smorgasbord. Both the outing and the smorgasbord are scheduled for Chillicothe. Any bowlers who do not have an established average (15 games or more bowled in a GAT league) may bowl and his or her average will be based on the three game total bowled during the outing.

In the company handicap tournament, the team event will be conducted in Portsmouth, and the doubles and singles competition will take place in Waverly.

To determine the entries for the telegraphic tournament the 60 top average bowlers in the company will be invited to compete in a roll-off. The 20 top scratch bowlers in the roll-off will be eligible to compete in the telegraphic event.

All male bowlers are eligible to participate in the scratch singles tournament. This will be a non-handicap tourney.

The company champion will be determined from his nine-game score in the men's handicap tournament (team, doubles, and singles) and his six-game score from the singles scratch tournament. Only scratch scores will be counted.

The first, second, and third places in all tournaments will receive trophies at the Banquet of Champions. The high average bowler in the company also will receive a trophy. He must be a regular bowler and have completed 60 or more games in a GAT league.
