

Fuller Retires; Pickens Named Successor

C. D. Tabor, General Manager of the Goodyear Atomic Corporation, recently announced an organizational change in the Industrial Relations Division, effective March 1.

Lloyd E. Fuller, Division Manager of Industrial Relations, has elect-

ed early retirement to be effective July 1, but due to accumulated vacation, his last day of active service will be February 28. The current Superintendent of Labor Relations and Public Communication at Goodyear Atomic, Fred E. Pickens, has been

chosen to replace Mr. Fuller.

Over 32 years of Goodyear service has given Lloyd a wealth of memories and experiences. He began his Goodyear career in September of 1942 in the time study department of the Los Angeles organization. In September of 1944 he became an interviewer in their employment department, then returned to his original department in January of 1945 as a Time Study Man, Sr. His next move was not long in coming. He was named Employment Manager in August of 1945, with less than three years service.

The opportunity to be transferred to the Corporate Headquarters in Akron enabled him to become an instructor in supervisional training and program development in March of 1949. He returned to Los Angeles in July of 1951 as Manager of Supervisional Training and as Assistant to the Personnel Manager.

Then came the news of GT&R participation in managing a gaseous diffusion plant in Piketon, Ohio, for

the Atomic Energy Commission. Mr. Fuller assumed the duties of Superintendent of Employe Relations in October of 1952, as a member of the original start up group, and was three and one-half years later named Superintendent of Personnel Services at GAT.

Opportunity knocked again in October of 1963 when Mr. Fuller was chosen for an international assignment. His first post was in India as Personnel Manager stationed at the New Delhi Tire Plant. He was transferred to the Goodyear Plant at Norrkoping, Sweden, in 1966, where Lloyd was Industrial Relations Manager for Sweden.

He returned to the U.S. to assume his present duties of Manager of Industrial Relations at GAT in August of 1968. Mr. Fuller and his wife, Gertrude, presently live at 18 Club Drive in Chillicothe, where they have been quite active. The future of this couple would have to include the type of a life they have enjoyed most. Mr. Ful-

GAT Honored by AEC

On January 15 the Atomic Energy Commission presented special citations to seven industrial organizations and universities for outstanding contributions to the nation's uranium enrichment and national security programs. Goodyear Atomic was one of the industrial organizations so honored.

Our citation reads as follows: Goodyear Atomic Corporation, subsidiary of The Goodyear Tire & Rubber Company, "is commended for outaining performance in the operation of the Atomic Energy Commission's Portsmouth, Ohio, Gaseous Diffusion Plant and in the continuing effort to improve the efficiency and production capacity of the gaseous diffusion process."

The citations were awarded by AEC Chairman, Dr. Dixie Lee Ray, in a ceremony at the Commission's Germantown, Maryland, Headquarters. Other citations were presented to

Union Carbide Corporation, Garrett Corporation, University of Virginia, University of California, Bendix Corporation, and Western Electric Company.

The U.S. AEC special citation was granted to Goodyear Atomic Corporation in recognition of more than 20 years of outstanding contributions and accomplishments in the nation's program of gaseous diffusion uranium enrichment.

Former PCDP Manager For The AEC Given New Assignment


Roy V. Anderson, a veteran of the U.S. atomic energy program, is serving as Chief of the Feed Materials Branch in the Uranium Enrichment Division of the Energy Research and Development Administration's (formerly the Atomic Energy Commission) Oak Ridge Operations.

In his new position Anderson is responsible for assisting in the administration of programs for the production of uranium "feed" materials, primarily at the ERDA's Feed Materials Production Center at Fernald, Ohio, and at a uranium metal extrusion facility in Ashtabula, Ohio. Feed materials are specific forms of uranium that are used for the production of enriched uranium or for the production of plutonium.

Anderson joined the AEC in 1952 as a chemical engineer assigned to the AEC's Fernald Area Office. He became Deputy Area Manager in 1957, staying at Fernald until May of 1962 when he became Manager of the AEC's Portsmouth (Ohio) Area Office at the Commission's Portsmouth Gaseous Diffusion Plant. He returned to Oak Ridge in May of 1974.

Directors of Goodyear declared a regular quarterly common stock dividend of 27.5 cents a share, payable March 15 to shareholders of record February 14.





Wise Owls Prove The Value Of Eye Protection

The Ohio Society for the Prevention of Blindness is an affiliate of the National Society for the Prevention of Blindness, the second oldest voluntary health agency in the nation (founded in 1908) and the *only* national organization dedicated solely to prevention of blindness.

Its programs consist of preschool vision screening, children age three-to-six, for amblyopia (lazy eye) and other visual defects; glaucoma screening (adults over age 35); Wise Owl Clubs (eye safety incentive programs industry and schools); public and professional education.

The Ohio Society provides service in all Ohio's 88 counties. It establishes operational procedures, trains the volunteers, provides support literature, and compiles statistical data on statewide results.

On December 19, 1974, Wise Owl Club membership certificates were presented to Mr. Ted D. Adkins and Mr. John Maple of Department 711 by Mr. J. J. Eyre, for their foresight in using eye protective equipment which saved their sight in an accident.

Also attending the award presentation were 21 previous members that work at GAT.

On August 28, 1974, Mr. Adkins, while working to restore power to a piece of equipment, went to a panel to turn off power to a breaker and as he did, the door came open and fire came out, striking him in the face and chest.

On September 19, 1974, Mr. John Maple was using a portable drill to attach a clip to a metal base. The drill bit hung and broke into several fragments. Part of the fragments were propelled back into the employe's left lens of his safety glasses. None penetrated the lens.

Mr. Nate Hurt, Deputy Manager, added his congratulations and stressed the importance of safety in all operations. He also complimented the two recipients for their foresight in preparing to work safely.


The leading cause of blindness today is cataract, followed by glaucoma, visual defects in children and eye accident. Diabetic retinopathy (a disease of the retina caused by advanced diabetes) is predicted to overtake cataract and glaucoma to become the leading cause of blindness in the coming decade.

Some 4,300 Ohio employes have saved 5,311 eyes by using safety glasses and other measures. Savings to their companies and to taxpayers in compensation alone are estimated at a minimum of \$21,000,000.

Beaumont Plant Rebuilds Facility

Goodyear's explosion-damaged isoprene unit at the Beaumont, Tex. synthetic rubber plant should be back in operation within four months, according to Chairman Charles J. Pilliod, Jr.

He also said the company has sufficient polyisoprene inventory to supply the market during this period.

The fire and explosion in th plant's isoprene manufacturing unit killed two persons and injured 10 others on Nov. 29.

Polyisoprene is produced at Beaumont by polymerizing a petrochemical derivative called isoprene to for... polyisoprene rubber.

Total damages caused by the explosion have not been finally estimated by the insurance assessors but are expected to be in the area of \$15 million.
