SENATORS BAKER AND TAFT VISIT GAT PLANTSITE

On Wednesday, October 13, U.S. Senators Robert Taft and Howard Baker took a brief tour of the Goodyear Atomic Plant facilities and also met with local media. The two Senators were met at the Pike County Airport by Charles Keller, Assistant Manager, Operations, for ERDA; Charles Tabor, Charles Mentges, Bob Boeye, and John Gedeon; as well as George Rucker from the UPGWA, and Bill Fields and Dennis Bloomfield from the OCAW.

Although the two Senators were on a tight schedule, as Senator Taft was running for re-election from Ohio, the two Senators wanted to tour the facilities at GAT in a non-political visit. They also wanted to express to the media their support for the add-on plant facilities here at GAT.

Both of the Senators expressed the feeling that the \$170 million portion of the Energy and Development Administration Bill "has to pass." The bill, unfortunately, cannot be reintroduced until Congress reconvenes in January. The authorization bill presented in the final hours of the 94th Congress died, "because of the personal ambitions of a single Democrat Senator," according to Taft. During an informal press conference on the berm of the main access road to the GAT Plant, Taft noted that the only reason for the filibuster by Senator Gravel (Alaska) was his desire for a position on the Joint Committee on Atomic Energy. Taft and Baker quoted the October 1 Congressional Record for substantiation of their allegations.

Taft also was quoted as saying that a continuing reliable source of enriched uranium is absolutely essential to our future energy needs. "The Pike plant is the key to meeting those needs, and I hold it among my highest legislative priorities."

Baker told reporters, "The general sentiment in the Joint Committee, of which I am the senior member, and Congress is set on the plant addition here. Even though I have a gaseous diffusion plant at Oak Ridge in my own state, Senator Taft and Congressman Bill Harsha convinced me this was the best place to

ERDA ISSUES GAT ADD-ON IMPACT REPORT

On October 15, the Energy Research and Development Administration issued for public comment a draft environmental statement on the proposed expansion of the Portsmouth Gaseous Diffusion Plant.

This expansion effort will provide new uranium enrichment capacity to provide nuclear power reactor fuel for existing contracts beginning in the mid-1980's. ERDA's plant here, completed in 1956 as part of the AEC's uranium enrichment complex, now includes three process buildings with a capacity of 5.2 million separative work units (SWU) per year. A SWU is a measure of the effort expended to produce enriched uranium.

When the Cascade Improvement Program and the Cascade Uprating Program now underway are completed in 1981, the capacity will be increased to 8.4 million SWU. The expansion here at GAT will add four process buildings with a capacity of 8.75 million SWU per year.

The draft environmental statement was prepared in compliance with the National Environmental Policy Act. A major impact will be the additional 3,500 to 3,700 megawatts of electrical power required for operation of the add-on plant.

Comments on the draft state-

ment will be considered in preparation of the final statement if received by ERDA by December 15, 1976. Copies of the draft statement are available for inspection at local ERDA installations and also at public libraries in our four-county area.

OCAW Strike

On Wednesday, October 6, representatives from the OCAW and the Company attended a hearing in the courtroom of the Federal District Judge in Columbus, Ohio. An injunction of picketing at the north access road to the plant facility was requested. The injunction was granted the following day. Contractors returned to their projects at that time.

During October, two meetings were held between the OCAW and the Company per the request of Federal Mediator, Howard Hughes. On Friday, October 1, the Union restated its position which the Company felt was not reasonable, resulting in the meeting being recessed. On Wednesday, October 28, the two parties again met. The Company reported that improvements in several areas were explored by the Company through the mediator, but were rejected by the Union. After a lengthy session, the meeting was again recessed subject to recall by the mediator.



Milone

C.R. (BUD) MILONE COMPLETES CAREER

Dr. C. R. (Bud) Milone's final interview as Vice President of Research and General Products produced several interesting highlights and observations. "Bud" was born on February 13, received security clearance number 13, and his house in Chillicothe was marked number 13 by the contractor. Despite the unlucky number, he looks back on good fortune and hopes for the future.

He joined Goodyear in 1939 as a research chemist and as a Supervisor in the Organic Chemistry Department prior to becoming a Research Division Section Head. When Goodyear was selected to operate a gaseous diffusion plant in 1952, Dr. Milone was named Superintendent of the research lab here. He became Manager of the Technical Division in 1957 and Deputy General Manager in 1960. Dr. Milone returned to Akron in 1967 as Director of Research and General Products. In February 1970 he was elected Vice President of Research and General Products Development.

One accomplishment that is of considerable pride to him is the GAT plant. "There were 28 of us and none of us knew a thing about what we were doing. To watch that plant — a \$760 million plant at the time — be built and go onstream without a ripple and do an outstanding job, gave me a big kick. It isn't often you have the chance to start with nothing and end with a plant like that."

In retirement he has few plans. "We plan to take a year to look around and decide whether we want to leave Akron." He plans to travel for that year, and, in summary, "I'm going to take advantage of that freedom."

From his many friends at GAT, much happiness and good health in retirement to "Bud" Milone.

GT&R SHOWS A \$5 MILLION LOSS

The four-month strike in the rubber industry plus currency devaluations in foreign operations resulted in decreased sales and a loss for the third quarter, Goodyear Tire and Rubber announced on October 20.

Third-quarter sales of \$1,307,400,000 were down 6.3 percent from the record \$1,394,900,000 set in the comparable 1975 period. Net income for the third quarter showed a \$5,300,000 loss compared with a restated and record third-quarter net in 1975 of \$55,400,000.

"Despite the excellent start-up in September, idle plant cost in

July and August plus the time required to fill the depleted pipelines in September had a negative impact on earnings during the last three months," Charles J. Pilliod Jr., Chairman and Chief Executive Officer, said.

Third-quarter earnings represented 7 cents per share loss compared with 77 cents per share profit in the same period of 1975. This is the first time Goodyear has had a loss for a quarter since the last half of 1937.

Despite the strike the ninemonth sales set an all time record for the period and were up 5.4 percent over the figure re-

corded in 1975. Nine-month earnings per share were equal to 96 cents compared with \$1.79 per share for the same 1975 period.

Pilliod said he is optimistic about the last three months of 1976 and expects that earnings will be "substantially ahead" of the comparable 1975 period. Price increases to recover the increased costs of products resulting from the new contract with the Rubber Workers are being put into effect and "the outlook for both the Tire and General Products Divisions of the Company is very healthy not only for the remainder of this year but also for 1977."

WATTS WINS SPIRIT AWARD

Recently, in a ceremony in the office of C. D. Tabor, Henry received a bronze medallion and a \$100.00 cash award for his selection.

His career with Goodyear started over 46 years ago in the Machinist Apprenticeship Program at Goodyear-Akron. After graduating from Akron University, he joined Goodyear in the Engineering Department. In October 1940 he transferred to Goodyear Aircraft, and to Goodyear Tire and Rubber in October 1945 as Purchasing Agent in Uitenhae, South Africa. He transferred to Goodyear Atomic in November 1952 and was promoted to Manager of Purchasing and Materials in April 1970.

Henry is the recipient of two Litchfield Awards. He also received the Certified Purchasing Manager Award. In the community he has been President of the Kiwanis Club, President of the YMCA Board of Directors and a member of the Chamber of Commerce.

Henry will retire shortly and plans to travel extensively as well as continuing to serve his favorite civic organizations. Under Division 2, Research and Development, of Goodyear Tire and Rubber, Henry will now compete against four other local winners for a Division Award.

good health in retirement. PENSION PLAN IMPROVEMENTS

Improvements have been made in the Non-Contributory Pension Plan for GAT hourly employes. As in the past, no payments can be made under the improved plan until the necessary amendments to the plan are fully approved by the Energy Research and Development Administration (ERDA) and the Internal Revenue Service.

ARE ANNOUNCED FOR GAT

HOURLY EMPLOYES

A revised pension booklet will be printed and distributed to all hourly employes as soon as possible after the date of final approval.

For employes retiring on or after May 1, 1976 the normal (age 65) pension rate will be increased to \$11.00 per month per year of service. For those retiring on or after May 1, 1977 (but before May 1, 1978) the pension rate will be \$11.75 and for those retiring on or after May 1, 1978 the pension rate will be \$12.50 per month per year of service.
