



Toll enrichment shipments highest ever

The volume of shipments of enriched uranium from the Portsmouth Gaseous Diffusion Plant during fiscal 1987 was the largest ever accomplished. Total product delivered had a separative work value of 10.37 million SWUs. This surpassed the record of 9.05 million SWUs shipped in fiscal 1986. All plant departments deserve congratulations for their role in completing this volume of shipment.

Corporate scholarship forms available

Forms are now available for high school seniors to apply for Martin Marietta Corporation Foundation scholarships. Sons and daughters of active employees are eligible.

Scholarship grants are remitted directly to the college of the appointee's choice. Grants are renewable annually for three years if the scholar maintains a satisfactory level of accomplishment. Candidates for scholarships should make applications to the regionally accredited colleges or universities of their choice as early as possible; academic records must qualify the applicants for unconditional admission.

There are two parts to the application forms. The first is the Scholarship Application, which the applicant completes and forwards directly to the Scholarship Selection Committee of the Martin Marietta Corporation Foundation in Bethesda, Maryland.

Simultaneously, the applicant will submit a "Request for Secondary School Information" form to his or her school principal, headmaster or guidance counselor to initiate action toward providing the Selection Committee with required academic records, test scores, counselor's report, etc.

Applications and all supporting evidence must be in the hands of the Foundation's Scholarship Committee in Bethesda, by February 1, 1988.

Forms are available at Portsmouth in the Public Relations Department, X-100 Building, M/S 1118/A.

All applicants are expected to complete the American College Test (ACT) battery or the College Entrance Examination Board Scholastic Aptitude Test (SAT) no later than December of their senior year.

Clean air group looks at policy for tobacco use

To assure that employees of the Portsmouth plant are working in a safe and healthier environment, a Clean Air Committee has been formed.

Studies have shown that almost onethird of the deaths related to lung cancer is caused by breathing cigarette smoke in the workplace. Smoke in a typical office environment, with average occupancy and ventilation, increases the risk of cancer to the nonsmoking employees from 250 to 1,000 times the allowable federal guidelines for carcinogens in air, water, or food.

The committee developed a plan that accommodates smoking only in areas where effective control of smoke is feasible and healthful working conditions can be maintained. This plan will be implemented on January 1, 1988.

Building custodians have determined "smoking" areas based on adequate airflow needed to eliminate the health hazards of side-stream smoke, and will post signs accordingly.

This plan is supported by union officials and management.



Fire Department has special training, open house activities

Two recent major activities of the Portsmouth Gaseous Diffusion Plant's Fire Department had the purpose of providing additional squad training and making site employees aware of their equipment and capabilities.

Firefighters conducted extensive live fire extinguishment training on September 14, 21, 28, and October 2 in the parking lot west of XT-847.

During each of the training sessions, firefighters set a 15 x 20 foot area of untreated wooden pallets ablaze to test their firefighting techniques.

Crews in full turn-out gear responded with a pumper, an ambulance, and a heavy rescue truck, the equipment used in any type of site emergency.

Responding firemen used attack lines that provided a minimum of 180 gallons of water per minute.

Stand-by crews were available with a pumper, supply line, and a "charged attack line to insure the safety of the firemen participating in the exercise and to provide optimum plant coverage should a real emergency occur.

According to Jack Harbert, training officer, no two practice fires were alike, the same as with real situations.

"Each response brings a new challenge and a new learning experience to our crews," Harbert stated. "The use of fire helped put realism into our training package."

A minimum of six employees from the site Fire Department respond to any emergency at the plant.


The department has mutual aid agreements with Pike and Scioto counties. There are 35 employees in the department, which is under the supervision of Jim Boyce.

Employees learned about the importance of fire safety and the duties of the department through an "Open House" conducted during National Fire Prevention Week October 5-9.


A guided tour of the fire station, displays of fire and rescue equipment, and practical hands-on experience were available to 170 attending.

Those who desired could dress in fire gear and experience the challenges associated with water pressures. The deluge gun, which is used on large structural fires, uses 1,250 gallons of water per minute. A foam nozzle attached to a 2½ inch line had pressure of 95 gallons per minute.

The department plans to make this an annual event.







"I really appreciate the company's help," stated Karr.

Scott Previously lost his father (who was also a smoker) to cancer and decided that he should quit the smoking habit. Scott had "quit" several times on his own over a 20-year period, but needed the reinforcement of others to be free from smoke. "Now when all else goes wrong, I can still say I did not smoke," Scott said.

The September Breathe-Free clinic is not officially over. Counselors will maintain contact with the attendees on a quarterly basis to check on their progress.

"Certificates of achievement do not truly measure the accomplishment of these attendees," Mays stated, "and for those smokers who need encouragement, the urge will pass - one step at a time."
