The water is being provided for plant neighbors in time of need and is not for re-sale. The program will continue until the present shortage is over.

Provisions were made to handle requests for filling containers ranging in size from gallon bottles up to large tanks. Plant neighbors must come to plantsite, bringing their own containers, and sign a register to acknowledge receipt of water.

The potable water is being provided from the plant's own drinking water supply, which is obtained from well fields along the Scioto River flood plain and treated at the X-611 Water Treatment Plant prior to use.

Both routine and special tests are being conducted to ensure the continuing good quality of the water being supplied to plant neighbors


Martin Marietta management consulted with the Pike County Commissioners, the Mayor of Piketon, Pike Water Company and the Piketon Water Department. All endorsed the plant proposal.

Activities on the first day of the water distribution included a visit to the site by Congressman Bob McEwen, local elected officials, water company officials and members of the news media.

Contract extended

The U.S. Department of Energy signed a modification Wednesday, June 29, formally extending its operating contract for the Portsmouth Gaseous Diffusion Plant with Martin Marietta Energy Systems, Inc., through September 30,

This date is concurrent with the expiration of the four-plant Oak Ridge and Paducah operating contract. The Portsmouth plant contract originally was scheduled to expire June 30, 1988.





GCEP use promoted

Use of the U. S. Department of Energy's Gas Centrifuge Enrichment Plant (GCEP) as the future location of a new Atomic Vapor Laser Isotope Separation (AVLIS) uranium enrichment plant is being promoted by the Ohio Valley Regional Development Commission's (OVRDC) GCEP Alternate Use Committee.

The committee is composed of Southern Ohio community leaders, and sent a letter July 11 to John Herrington, Secretary of Energy, to propose use of GCEP as the site for a fullscale AVLIS plant in the 1990s.

At June 27 President's Forum

Hopkins discusses organizational values

More than 300 Energy Systems managers heard presentations by President Clyde Hopkins and Senior Vice President Herman Postma on the company's progress, new directions and organizational values June 27 at the second President's Forum at the Oak Ridge Associated Universities' Pollard Auditorium.

Hopkins began by pointing out events of the past several years — including a new DOE-ORO manager, a new operating contractor, and the Bhopal, Challenger and Chernobyl incidents — that have contributed to increased pressure on the company to do things differently.

"In my first 150 days as president, I've tried to do more listening than ever before, to employees, managers, DOE, Martin Marietta and others," he said. He then described what he believes are some concerns of various key groups, adding that their attitudes affect the way the company must approach its missions.

• The public, he said, thinks that there is no danger of another energy crisis; that the defense budget is too large; that the primary consideration involving nuclear power is safety; that all risks to public safe-

ty and the environment must be minimized; and that members of the scientific community, rather than holding all the answers to today's problems, have become somewhat self-serving.

- He said Energy Systems employees expect more participation in decision making, access to managers, freedom of job opportunities (including a solution to the "Q" clearance issue), and efforts to ensure job security; a safe work environment, and a more efficient, competitive company.
- Hopkins said DOE's concerns, "which will become ours as well," are largely based on those expressed by the public and by Congress. They included continued high performance with improved efficiency and effectiveness; help in anticipating and solving future problems; and continued emphasis on health, safety and environemtnal issues, quality assurance, safeguards and security, and equal employment opportunity. Postma said that to deal with the new environment created by those concerns, top management, in a series of offsite meetings has identified five key issues to be addressed during the coming months:

• The need for better team work among all employees — including union membership and leaders, salaried employees, and managers — and with DOE. This will involve improved communication through more management employee meetings and a commitment to "management by walking around."

Smoking policy

A smoking policy was implemented on the Portsmouth Gaseous Diffusion Plant site effective Aug. 1

Smoking is prohibited in conference and meeting rooms, auditoriums, elevators, lobbies and restrooms, unless otherwise posted; stairwells; medical and fitness facilities; cafeteria and lunch rooms except where otherwise posted; libraries; confined spaces, open or closed, where ventilation does not permit safety or comfort; and areas containing explosive or flammable hazards

Smoking will generally be permitted in posted areas outside auditoriums and conference rooms; posted areas in cafeterias; posted areas at worksites; outside the building; in closed single occupant offices and guard posts (the occupant will not smoke when a nonsmoker is present and it is the obligation of the smoker to determine whether a nonsmoker is present); multiple occupant office areas if all occupants are smokers; posted areas in locker rooms; a limited number of posted restrooms in buildings where multiple restrooms exist; and in posted areas in aisles and hallways.

Advisory committee has ninth meeting

The Martin Marietta Energy Systems Environmental Advisory Committee for the Portsmouth Gaseous Diffusion Plant met for its ninth session June 23 and 24.

The committee's agenda included an informal meeting with a representative of the Ohio Environmental Protection Agency to discuss environmental issues of mutual interest.

The committee then looked at operation of the plant's new Emergency Control Center during a practice exercise June 23. Several members of the committee expressed their intent to serve as observers at the full-scale emergency exercise of July 23.

The committee also reviewed the operation of sampling systems used to monitor airborne radioactive material releases from plant process buildings. These systems have been upgraded over the past two years.

- The need for better management training, particularly in safeguards and security impacts, environmental concerns and regulations; quality; radiation protection; and transportation of toxic and radioactive materials. All these efforts should be based on Energy Systems' values, Postma said.
- The need for better communication, with special emphasis on communicating company values.
- The need for an even greater commitment to quality in all Energy Systems operations, particularly those characterized as "critical facilities."
- The need to be the best DOE contractor. This requires excellence in all of our mission areas.

Continuing on this "Be the Best" theme, Postma announced the approval in principle of a "President's Fund" to help pilot and provide overhead funds for new and better ways of doing things across Energy Systems. He said more information about the fund will be announced when all criteria have been developed.

Another aspect of the "Be the Best" effort will involve recognition by Hopkins of employees who make special contributions to Energy Systems through outstanding performance on a particular project or through professional achievements.

After Postma's remarks, Hopkins_presented Energy Systems' values (see accompanying box), which he said top management have been developing for several years.

"We've thought about these values very seriously, but they're not carved in stone." Hopkins said. "we want and need your input." Employees are encouraged to review the values and to submit their comments and suggestions through their line management.

Monitoring report is issued

Energy Systems and DOE-ORO issued calendar year 1987 environmental monitoring reports May 25 for areas surrounding the Portsmouth, Oak Ridge and Paducah facilities.

The reports, the latest in an annual series, gave the results of a comprehensive year-round program to monitor the impact of site operations on area groundwater, surface waters, soil, air quality, vegetation and wildlife.

At the same time, DOE issued a report summarizing the history of radionuclide releases from ORO facilities and the calculated radiation doses to the public within a 50-mile radius of each.

College graduate

Cynthia G. Hollis, daughter of Sue F. Hollis (D-332), was graduated from the University of Cincinnati's McMicken College of Arts and Sciences.

The reports were made public in each area in simultaneous news media briefings.

The environmental surveillance report contains results of analyses and investigations of approximately 100,000 measurements of air, soil, groundwater, streams, drinking water, food crops, grasses, fish, refuse, sewage, sediment and sludge.

The DOE report on historic radionuclide releases was a follow-up to a 1985 report on historic uranium releases prepared as a result of news media inquiries, requested by ORO Manager Joe La Grone, with the purpose of ensuring that all known data on radionuclide releases are made available to the public.

The report concludes that radiation doses to the population around DOE-ORO facilities from radionuclide releases are only a small fraction of doses due to background radiation, and that health effects that could be attributed to these releases are small.






