IN A PRESS INTERVIEW, President Gerald Ford was asked his opinion of the 1976 ballot initiative that would ban further nuclear plant construction and operation in California. Here is a portion of his response: "I think in light of our serious, almost critical energy shortage, that it is unwise for any state to ban the development and the utilization of nuclear power in the future ... It would potentially--I don't say certainly, but potentially--interfere with the economic development of the great State of California ... I think there is a better approach than an arbitrary ban because the safety record so far and the prognostications of responsible people indicate to me, at least, that the danger is not a serious one, and if there are any problems, they can be resolved."

SUCCESS of the American Bicentennial will be judged by the number of participants, not spectators. With that oft-stated theme once more repeated, the American Revolution Bicentennial Administration reports the number of scheduled projects or events now at over 27,000. About 8,000 communities that contain about three-quarters of the U.S. population have been officially recognized for their Bicentennial plans. The administration has set a January 31 cutoff date for license applications to manufacture ARBA-approved Bicentennial items.

THE WALL STREET JOURNAL reported that a man in Atlanta consulted five different firms about his taxes. The C&M Tax Service told him his tax bill was \$838.08 (their fee was \$31). Sears told him he could expect a refund of \$30 (fee: \$15). Mr. Tax (another consultant) told him he owed an additional \$565 (fee: \$26). H&R Block in Decatur told him to pay \$597 (fee: \$22.50). When the man finally checked with Georgia tax officials and the Internal Revenue, they told him he was entitled to a refund of \$518.74! Moneysworth recommends that you pay 75¢ for a copy of "Your Federal Income Tax" from district offices or from the Superintendent of Documents, Washington, D.C., 20402, and prepare your own tax forms.

SEAMANS SALUTES ERDA PROGRESS ON ANNIVER-SARY. Important progress has been made during ERDA's first year in development of a national energy research and development plan, Administrator Robert C. Seamans, Jr. said in a statement issued on the agency's first birthday, January 19.

Significant steps have also been made in "mobilizing the talent and taking the organizational steps necessary to move aggressively ahead in the development of this nation's resources," he said. "These steps will pave the way for achieving self-sufficiency in energy."

ERDA was created by the Energy Reorganization Act of 1974 and came into existence on January 19, 1975, placing in a single agency the energy research functions formerly carried out by several federal agencies.

U. S. FAMILIES retain home freezers an average of 20 years, longer than any other major appliance. Dishwashers and washing machines have the shortest average life, 11 years.
