ENGINEERING

J. L. SCHWENNESEN of DOE (Washington) was quoted in the October 17 issue of Nuclear Fuel as reporting that "the cost of separative work at the projected centrifuge plant will be about one-third less than the cost of diffusion separation, despite a 25% higher capital cost--with still greater savings probable as centrifuge technology matures." He also used a new, lower number on the centrifuge's need for electricity, saying it was only 4% of the diffusion requirement per swu. He also pointed out that the Carter Administration has made no decision on whether to have three separate industrial contractors participate in designing and operating the last three units. DOE will build and operate the first unit, and would save some \$500 million by doing this with all four 2.2-million swu units, but it wants to give private industry a foundation for building its own centrifuge facilities.

RESTRICTIVE LEGISLATION and innovations such as the studless winter tire have severely reduced the need for tires equipped with studs, a market that once totaled over \$50 million. Goodyear introduced the F32 studless winter tire in 1974 and the demand has remained very high. Continuing development in that area, the Tiempo tire which was recently introduced, combines the desirable features of winter and summer tires into the really first all-season tire at an economical price.

NATE HURT was the featured speaker at the annual Pike County Chamber of Commerce Banquet held recently. His presentation was a review of Goodyear Atomic Corporation including humorous stories from the early construction period.

TOTAL ENERGY USE in the U.S. rose 4.8% from 1975. This reverses a two-year decline, but remains under the consumption record of 1973. The energy figures indicate that conservation efforts, especially in the industrial sector, prevented an even higher growth rate in total energy use during 1976.
