Contract Awards

The Howard P. Foley Co., Richmond, Va., was the apparent low bidder on a contract for process control and data acquisition systems and local control centers (PCDAS-LCC) installation for Process Building X-3001, Process Support Building X-3012, Central Control Building X-3000 and Pumphouse/Air Plant Building X-6000 for the Gas Centrifuge Enrichment Plant (GCEP). The Foley bid of \$1.68 million was one of eight received by the Portsmouth Area Office of the U. S. Department of Energy.

The Sherman R. Smoot Co., Columbus, has been awarded a \$1,819,152 contract for Guard Precinct Station X-1020 for GCEP by DOE-PAO. The company will furnish all labor and material to construct a 7,500 square foot, single story, station which will be used to house the guard force for both GDP and GCEP.

Business and Industry

According to recent newspaper stories (Wall Street Journal and New York Times), even though 1982 car sales dropped 6.3 percent to 7,978,487 units from 1981, Detroit's Big Three reported increased sales for the seventh consecutive 10-day period as the year ended. Car output is expected to rise 35 percent above 1982 levels in the first quarter. In the 10-day period ended Dec. 31, new car sales rose 26.4 percent compared with a year earlier.

The Goodyear Tire & Rubber Company has advised Goodyear Atomic that any employee who is on recallable layoff is eligible for tire refunds through 1983. The one-year maximum eligibility from date of layoff has been waived for this year. At the end of 1983, the policy will be reviewed to determine future eligibility requirements for tire refunds for laid-off employees. It is the responsibility of the Personnel and Equal Employment Opportunity department to approve all tire refunds for laid-off employees. News from Goodyear

Employees will have an opportunity to view a "theatrical blockbuster" on television in February when Goodyear sponsors "The Winds of War" over seven nights. In urging employees to see this 16-hour novel for TV, Scott Buzby, executive vice president and president, Tire Division, said, "The Winds of War" promised to be one of the most outstanding TV presentations of 1983. "It will be well worth watching," he said. "The film not only is entertaining, but provides historical and political perspective on how World War II developed." The novel was adapted for ABC-TV by the author, Herman Wouk. It will be seen in Southern Ohio over WOWK-TV (Huntington) Channel 13 and WTVN-TV (Columbus) Channel 6 starting Feb. 6 from 8 to 11 p.m. It is scheduled Feb. 6 through Feb. 11, skips Saturday, Feb. 12, and returns for conclusion on Feb. 13. The times are 8 to 11 p.m. (EST) except on Feb 8-9-10 when it will be seen from 9 until 11 p.m. Goodyear commercials on those seven nights will feature Arriva and Eagle tires and automobile service, emphasizing the fact that Goodyear radials outsell all foreign competitors combined and is Number One in radials.

The Paul W. Litchfield Awards Association, formerly the Goodyear Service Pin Association, is continuing its sponsorship of scholarships at the University of Akron and Kent State University for sons and daughter of Goodyear employees. Also eligible are children of retirees or deceased employees. Applications at either university are to be made at the financial aid offices of the schools. These are the only two schools where these scholarships are offered. The deadline for University of Akron applications is April 1, and at Kent State it is June 1. High school seniors who may be applying at either school should call the University of Akron at (216)375-7032 or Kent State at (216)672-2972 for the application forms on which to specify the parent's employer. Selection committees at the schools are solely

responsible for selecting and advising the successful applicants. For 1983 the scholarships carry stipends of \$600 per school year. Funds are to be used for tuition, fees and books before being disbursed for other expenses. Four years is the usual maximum length of a scholarship. Normally, a scholarship will be renewed annually until graduation so long as the recipient remains at the university and maintains a satisfactory academic record. Other details of the scholarship program are available in a brochure that can be obtained in the College Relations section of the Goodyear Personnel Department in Akron.

Thomas E. Wightman, assistant treasurer of Goodyear and vice president and treasurer of its International subsidiary, has been elected a vice president of the parent company.

Directors of The Goodyear Tire & Rubber Company Jan. 11 declared a regular quarterly dividend of 35 cents per share payable March 15 to shareholders of record Feb. 15. The dividend payment represents an annual rate of \$1.40 a share. Goodyear stock went up by 84 percent from 1981 to 1982, going from \$19 per share to \$35 per share. It rose second highest in the Dow Jones Industrial Average. According to the New York Times, when the Dow Jones Industrial Average hit a record high of 1,070.55 in late December, five of the 64 stocks that traded at their highest in 52 weeks were rubber stocks: Cooper, Firestone, Goodyear, Mohawk and Bandag. Merrill Lynch projected 1982 Goodyear net income at \$3.25 a share, down from \$3.36 in 1981, but forecasts 1983 earnings of \$4.50 a share.
