Contract Awards

Of 10 contractors, Thermo Contracting Corporation of Brick, New Jersey, was apparent low bidder at \$309,158 on a contract to furnish all labor, materials and equipment required for replacement or repair of roofing and related carpentry and sheet metal work on Gaseous Diffusion Plant buildings X-100, X-330 and X-700.

William Cargile Contractor, Inc., Cincinnati, was apparent low bidder of 10 firms on a contract for a new cylinder storage slab for the Gasous Diffusion Plant. Its bid was \$297,948. The new storage slab will measure 88,000 square feet by nine inches thick. The contractor also will provide the lighting system and related earthwork and electrical work.

Nuclear Notes

U. S. nuclear generation hit a record high for a single month in January and provided 14.4 percent of the nation's total at a time when many regions were experiencing arctic cold weather. The January nuclear output was 30.8 million gross megawatt-hours. This surpassed the previous high of 29.1 million gross megawatt-hours set in January 1979. Nuclear's 14.4 percent share of U. S. gross electrical generation in January compares with the 1983 average of 12.6 percent. During the first eight weeks of 1984, demand for electricity was 7.4 percent above the year-earlier rate. The increase is not believed to be weather-related, because the number of degree days was virtually the same as in 1983.

Martin Marietta Energy Systems, Inc.

Martin Marietta Energy Systems, Inc., assumed full responsibility April 1 for the operation of DOE facilities in Oak Ridge and Paducah, Kentucky. During a public ceremony at the American Museum of Science and Energy, Joe LaGrone, manager of DOE's Oak Ridge Operations, and Kenneth

Jarmolow, president of Martin Marietta Energy Systems, Inc., signed the contract assigning the company responsibility for operating DOE's Oak Ridge National Laboratory, Y-12 Plant, the Oak Ridge Gaseous Diffusion Plant and the Paducah Gaseous Diffusion Plant. The contract replaces one signed by DOE and Martin Marietta on December 22, 1983, which covered a phase-in period for the company to prepare for full operating responsibility. The new contract covers an initial period of five years and six months, the first six months of which will be a cost-plus-fixed fee and the remainder being a cost-plus-award fee. This ended a 41-year period during which Union Carbide Corporation, Nuclear Division, operated the government-owned facilities. Union Carbide announced in 1982 its intention to withdraw as DOE's operating contractor for the facilities. Union Carbide now has an administrative office in Oak Ridge for conducting closeout of the company's contract affairs not associated with the functions and responsibilities assumed by Martin Marietta.

Ralph G. Donnelly has been appointed manager of the Paducah Gaseous Diffusion Plant. He succeeds Clayton D. Zerby, who was recently named director of Operational Systems Development for Martin Marietta Energy Systems, Inc. Donnelly has been director of the Process Support Division at Oak Ridge Gaseous Diffusion Plant since January 1982. In the newly created position, Zerby will have responsibility for developing and implementing programs of operational and quality improvement and cost efficiency. Zerby's new position will operate from the Y-12 Plant, but will encompass all four facilities in Oak Ridge and Paducah.

News from Goodyear

Goodyear said it is disappointed by the verdict reached April 4 in the trial involving the company and the family of former race car driver Mark Donohue. A Providence, R. I. jury has awarded \$9.6 million to the Donohue family. Goodyear said it intends to appeal several issues involved in that case. Donohue died while driving for the Penske Formula One team during an August 1975 practice session for the Austrian Grand Prix. The jury found both Roger Penske Inc. and Goodyear liable and negligent and Donohue not negligent. Following the jury decision, the judge ruled in favor of Penske in its cross claim suit against Goodyear. if the jury verdict is allowed to stand, Goodyear will be responsible for paying an estimated \$19 million when interest is calculated, newspaper accounts said.
