News from DOE

Joseph F. Salgado, formerly an Associate Director of Presidential Personnel at the White House, was sworn in May 20 as Under Secretary of the Department of Energy. His nomination to the position by President Reagan was confirmed by the full Senate on May 15. He succeeds W. Patrick Collins. Salgado also has been named Chief Operating Officer for the Department. In an organizational move shortly after the swearing in, Secretary Herrington announced that the Under Secretary will assist the Secretary in overall Departmental program management with emphasis on research and development. "Specifically, the Under Secretary will oversee DOE programs involving research, development, testing, production, operations, environmental, safety, health, emergency preparedness, international affairs, regulatory, energy information and related programs," the announcement said. "He will also continue to bear primary responsibility for energy conservation. In addition, the Under Secretary was assigned responsibility for establishing DOE policy and overall guidance for the R&D laboratory technology transfer program. Secretarial Officers will continue to have primary responsibility for overall management of their assigned programs, the Secretary said.

News from Goodyear

Goodyear is looking for qualified minorities interested in operating their own tire and auto service centers. Using the slogan, "Go into business for yourself -- but not by yourself," the company is seeking minorities interested in owning and operating Goodyear dealer franchises in cities and communities around the country. "We're looking for minorities who have had experience in the retail tire and/or automotive service business, or a strong background in retail sales," said Matthew Brown, Goodyear's manager of dealer development. This includes those already in the retail tire business who want to expand. Minorities who enter the company's franchised dealership program are supported by Goodyear training, advertising and marketing assistance every step of the way. A strong minority tire dealer network produces jobs and keeps profits within the community, Brown said. "We are demonstrating that private enterprise can work successfully for minorities around the country. The total automotive retail aftermarket is a multimillion-dollar-a-year business, which makes the Goodyear program a business opportunity minorities should learn more about." Goodyear reported that the Federal Bureau of Land Management has issued a permit for a California-to-Texas crude oil pipeline to cross federal lands along its route. Robert E. Mercer, company chairman, said the major necessary permits for the project are now complete. Construction of some segments of the 30-inch diameter pipeline already are underway. "With the Bureau of Land Management permit now in hand, we are confident we will meet our scheduled completion date in the first quarter of 1987," Mercer said. Initially, the pipeline will have the capacity to transport 300,000 barrels of offshore California crude daily to refineries in the Gulf Coast area.

Tire imports continued to set records during the first quarter of 1985. Commerce Department figures show 8.11 million auto tires entered the U. S. in the first three months, topping the year-earlier period by 12.3 percent. January recorded the highest and March the third highest monthly totals ever. Meanwhile, medium and heavy truck tires from overseas were up 18.6 percent and light truck tires 50 percent. Radials dominated the auto and medium/heavy truck tire totals. For all of 1984, the inflow of tires was the highest for any year in history, reaching 30 million auto units and 6.5 million total truck units. Spurring these high levels was a short supply of radials. Although supply has caught up with demand this

year, there are three reasons foreign competition hasn't cooled off, according to Thomas F. Will, manager of management information: (1) The value of the dollar remains high in relation to other currencies — giving imports a price advantage over tires made in the U. S.; (2) Demand for tires still is sluggish in many areas of the world; and (3) The U. S. is the largest tire market and the easiest to enter. Taking advantage of their price advantage, overseas producers, especially those in developing countries, continue to target on America. South Korean marketers, for example, sharply increased their shipments of both auto and medium/heavy truck tires to the U. S. during January-March, closing in on Canada's No. 2 position behind Japan in both categories. In the face of these trends, Will noted, imports are increasing their share of the U. S. replacement markets from the 21 percent reached last year in both auto and total truck tires.

Lotus of England is the latest producer of prestige cars to feature Goodyear Eagle high-performance tires as original equipment. It is mounting the Eagle VR "Gatorback" on its 1985 Excel coup. Nearly 90 percent of motorists ordering Excels are aksing for the "Gatorback" tires, according to the company. Lotus is one of a growing number of foreign automakers to equip major models with Eagle radials. At the same time, U. S. producers are putting Eagles on eight out of 10 of their high-performance cars. For 1985, "Gatorback" tires also equip the General Motors Corvette, IROC-Z Camaro and Trans Am with special performance package; the Chrysler Laser, Dodge Daytona Turbo and Shelby II; and the Ford Mustang 5.0 GT, SVO Mustang and Thunderbird Turbo. All Ferraris sold in the U.S. come with Eagle tires, some of them VR "Gatorbacks." Goodyear also is a major supplier for cars the Italian company sells worldwide. Among other prestige cars on which speed-rated Goodyear radials manufactured in Europe appear are the BMW 520i, Porsche 944 and 911 Carrera, Audi 200 and 200 Quattro, Saab 900 Turbo and Rolls Royce Silver Spirit. Eagle GT speed-rated tires are on the Volkswagen GTI, Motor Trend magazine's "Car of the Year" for 1985, as well as Dodge Shelby-Chargers and some Camaros, Trans Ams, Lasers, Daytonas, Mustangs and Thunderbirds. Japan's Nissan features standard Eagle GT tires on the 300 ZX Turbo models it Eagle GTs are also on the Camaro Z-28, and Pontiac's 6000SE and Fiero. sells in the U. S.
